Course structure

1 A Just Transition for a Circular Economy

This is the introductory module of the course. It focuses on the key foundational areas of the course; that is Circular Economy (CE), Just Transition and Sustainable Development Goals (SDGs).

The module introduces the participants to the key principles of CE and provides them with guiding exercises aimed at helping them diagnose and reflect on CE adoption within their ecosystems. It also introduces the concept of Just Transition, helping the participants to understand what it means, the key dimensions of the Just Transition framework (principles) and how they can be incorporated in the CE implementation.

2 Circular Economy Landscape Mapping and Diagnostics

This module is aimed at guiding the participants to carry out an extensive ecosystem analysis in their industry/sector with the aim of:

- Understanding the CE status in their country with a focus on their industry/sector.
- Carrying out a Gap Analysis to identify the existing gaps and opportunities.
- Identifying their target areas for impact and potential stakeholders they can work with.

3 Innovations for Circular and Social Impact

Understanding the social impact of CE interventions begins with laying a solid foundation based on social inclusion principles for holistic solution development. This begins with having a systematic approach to CE innovations. This module is structured around understanding CE innovations, understanding system thinking and designing interventions with the end in mind. The module also introduces various sustainability models and ESG reporting for sustainability reporting.



Develop an Inclusive, Circular Business Strategy

This module focuses on the technical aspects of running a circular business. It discusses the concept of CE maturity & life cycle assessment (LCA) in detail as well as the CE business models and the shape/form they take along the maturity ladder.

The module allows the participants to carry out a maturity/ LCA in a practical manner as well as define the shape/form of a business model along the maturity ladder. Participants will understand how to embed social inclusion principles in their circular business models to ensure social impact measures are included and accounted for.

5 Impact measurement for Circular and Social Dimensions

This module introduces participants impact measurement methodologies, dives into identifying different key impact measurement metrics, connecting impact to business and communicating impact to customers.
